In the event of any violation / infringement of the above said conditions and / or the provisions of Anna University, Chennai Act / Statutes / Regulations, AICTE Act, norms & standards / regulations / guidelines / Requirements of the State Government or any other law being in force, suitable action including suspension / withdrawal of affiliation of course(s) may be initiated against the college.
- **Deficiencies of the above Conditional Affiliation Course(s) be rectified within 30 days from the date of granting affiliation for the academic year 2025-26.**
- The University reserves its right to inspect the college, whenever required to verify the continued fulfilment of the affiliation norms, as prescribed by the University for the programmes concerned.
- Students should not be admitted for the above course(s) for the next academic year 2026-2027 without obtaining the order of continuation of provisional affiliation for the next academic year from the University.
- Any due amount arising in future for the payment of GST / Service Tax applicable for the previous academic years and current academic year may be collected from your College, subject to the directions of the Syndicate.
