

27.1 OBJECTIVES

The objective of this policy is to ensure that PERI Institute of Technology (PERI IT) is accessible and inclusive, providing equal opportunities and support to all students, including those with disabilities.

27.2 INFRASTRUCTURE ACCESSIBILITY

- **Ramps and Handrails:** All buildings at PERI IT will be equipped with ramps and handrails to ensure accessibility for wheelchair users.
- **Accessible Toilets:** We will provide accessible toilets equipped with facilities for use by disabled individuals.
- **Elevators:** Multi-story buildings will have accessible elevators with features such as braille buttons and audible signals.

27.3 LEARNING AIDS AND ASSISTIVE TECHNOLOGIES

- **Provision of Assistive Devices:** PERI IT will offer assistive devices such as screen readers, magnifiers, and hearing aids to students who need them.
