

3.1 INTRODUCTION

Peri Institute of Technology is committed to ensuring financial constraints do not hinder talented and deserving students from pursuing their education. To this end, the Institute offers a range of scholarships under its Free Ship policy, aimed at supporting students from diverse backgrounds, particularly those facing economic challenges.

3.2 CATEGORIES OF SCHOLARSHIPS

The Free Ship policy includes scholarships under five main categories:

1. Single Parent Scholarship
2. Elite Students Scholarship
3. Economic Weaker Section Scholarship
4. Scholarship for Sons and Daughters of Farmers (excluding Chennai)

3.3 ELIGIBILITY CRITERIA**1. Single Parent Scholarship**

- Open to students raised by a single parent due to the demise of one parent or other circumstances leading to single parenthood.
- The student must maintain a minimum academic performance as specified by the Institute.
- Annual family income should not exceed INR 1, 50,000.
- Maximum fee waiver: INR 20,000, limited to 20 students per year.

2. Elite Students Scholarship

- The student must have more than 175 cut-off marks in their qualifying examinations.
- Annual family income should be less than INR 2,00,000.
- Offered a INR 25,000 scholarship along with a INR 50,000 waiver in hostel fees for deserving candidates.



- Limited to 10% of the total intake of the institute.

3. Economic Weaker Section Scholarship

- Open to students from economically weaker sections.
- Annual family income should not exceed INR 1, 00,000.
- Offered INR 25,000 scholarship for deserving candidates.
- Limited to 10% candidates per academic year.
- Students must provide income certificates and other necessary documentation to verify financial status.

4. Scholarship for Sons and Daughters of Farmers (excluding Chennai)

Eligibility:

- Open to students who are children of farmers, excluding those residing in Chennai.
- The student must provide proof of their parent's occupation, with verification by the Institute.
- The student must have a satisfactory academic record as specified by the Institute.
- Preference given to those from marginal and small farming backgrounds.
- Selected candidates will receive an INR 15,000 scholarship in tuition fees per year, limited to 10% of the intake of the Institute.

3.4 APPLICATION PROCESS

1. Obtain the scholarship application form from the Institute's scholarship office.
2. Complete the application form with accurate and complete information.
3. Attach all required documents, including proof of eligibility, income certificates, academic records, and other specified documents.
4. Submit the completed application form and documents to the scholarship office by the specified deadline.



3.5 SELECTION PROCESS

- The scholarship committee will review all applications based on eligibility criteria and supporting documents.
- Shortlisted candidates may be called for an interview or additional verification.
- Final selection will be based on merit, need, and adherence to eligibility criteria.

3.6 RENEWAL OF SCHOLARSHIP

- Scholarships are renewable annually based on the student's academic performance and adherence to the Institute's code of conduct.
- Students must submit a renewal application with updated documents and academic records at the end of each academic year.

3.7 TERMS AND CONDITIONS

- The Institute reserves the right to modify or discontinue the scholarship policy with proper notice in cases of underperformance from students.
- Misrepresentation of information or violation of Institute policies will result in immediate termination of the scholarship and may require the student to repay the funds received.
